The Product Specifications Explained

Tick Value

The “Tick” is the minimum amount that the price or value of an instrument may fluctuate pursuant to the market rules of the relevant regulated market. As profit and loss is converted into the account currency, a “Tick Value” is associated with each product and automatically converted to the clients’ accounts currency.

For example, if the trading account is denominated in USD, then profit and loss will be calculated in USD. If a client traded in the UK100.c, which is priced in GBP, GBE brokers will automatically convert profit and loss into USD. The Tick Value details conversion rate in this example, would be the GBP/USD exchange rate.

Minimum and Maximum Ticket Size

The minimum and maximum order size is the smallest and/or highest increment accepted and applicable to all order types. The indicative minimum and maximum trading sizes for each instrument are included in this product specification list below.

Trading Steps

“Trading Steps” relates to the minimum order size increment accepted and applicable to all order types. For example, if a client trades in AUS200.c and orders a ticket size of 0.1, 0.2, and 0.3 lots will be executed by GBE brokers, but an order with a ticket size of 0.11 lots will not be executed in as much as the minimum allowed ticket size for AUS_200 is 0.1.

Therefore, clients are only able to trade in the minimum ticket size or multiples thereof. The minimum and maximum trading steps for each instrument are included in the product specification, which you can see in a few pages.



Contract Size

GBE brokers utilises a lot based trading system, which means that all GBE brokers products are aggregated into standardized trade sizes. This simplifies trading by allowing clients to trade in lot increments, and it also provides a price for each lot size rather than averaging open and close prices when multiple positions are taken in the same instrument.

Standard Leverage

Clients who have been classified as “retail clients” upon establishing a business relationship with the GBE brokers shall be granted by default with a leverage of 1:30. Clients meeting all criteria to be categorized as professional are able to trade with another leverage.

Minimum Margin Requirements

Margin requirements differ by the type of instrument and may be subject to change according to the underlying liquidity and volatility of the instrument. GBE brokers Margin Requirement Rates are displayed in the product specification list below.

Trading Hours

GBE brokers trading hours for CFDs products are based on when their underlying reference markets are open, or the times liquidity providing partners are streaming prices. During session hours, clients are able to set pending orders, open and close trades, and to adjust price levels.

GBE brokers CFDs will not be open for trading during holidays on which the reference markets are closed. When the market is closed, clients will not be able to take any action on positions or pending orders.

Session Break

Clients should also be informed that CFD products have an intraday break in addition to a daily closing time. Clients will not be able to adjust or close existing positions, or open new positions during the session break. All trading functionalities will cease upon the end of the week’s closing.



Financing Costs

Finance Charges - Overnight Rollover

GBE brokers daily interest debit or credit amounts (hereafter “rollover”) are based on the total face value of the open positions, and it will not be debited / credited on a position that is opened and closed on the same trading day.

All open positions are rolled automatically to the next trading day depending on whether an order is long (buy) or short (sell). It could either be debited or credited with rollover interest on a daily basis.

Please note that all open positions in FX and Metals products at the close of business on Wednesday incur a 3-day rollover debit/ credit, whereas clients’ positions in CFDs based on Indices, Energies, Treasuries and Equities that are open at the close of business on Friday will incur 3-day rollover.

Bank holidays will affect the number of days that a position is rolled forward. Details of GBE brokers rollover rates (swaps) are available in the GBE brokers MT4 Trading platform and on our website.

Swap Free Islamic Accounts

GBE brokers offers Islamic (swap-free) accounts to comply with Islamic Shariah law. This is also an advantage for all traders who hold their positions for multiple days without being aware of swaps or overnight fees; thus, a trading account would not pay, or be paid for holding a position for more than one business day**.

Any client who misuses this advantage by holding his floating positions for more than 10 business days, taking advantage of the swap-free facility, and gaining profits from swaps will be charged \$10 / lot every day, bearing in mind that these fees are handled by GBE brokers.

Furthermore, hedging a currency pair by its corresponding Future CFD and / or hedging positions on a swap based account against positions on a swap free account is forbidden, because these also represent attempts to take advantage of the swap free facility and gain profits from swaps; one direction of this kind of hedge must be closed immediately, otherwise both accounts will be subject to a daily storage fees as well.

Moreover, certain instruments will be charged Storage Fees on a daily basis as shown in the table below.

If the client fails to act to avoid such practices, GBE brokers will be required to close or take any necessary action on these accounts without prior written notice.

After day 10, three days storage will be applied every week on Wednesdays.

**Carry Pairs positions (TRY, MXN, ZAR) will be charged from day 1 as mentioned above.

Finance Charges Calculation for Forex & Equities

To calculate the charges, please use this formula:

(lots * Swap for Long or short in points)

Here's an example:

Long (Buy) 0.01 Lot EURUSD, Swap rate for Long is -7.922 points. The end of day market rate is 1.19097 for EURUSD. The client's account currency is EUR.

Therefore, the Swap Rate Calculation is as follows: $0.01 * (-7.922) / 1.19097$ (conversion to account currency) = - €0.07.

Here's an example:

Short (Sell) 0.2 Lots EURUSD. The Swap rate for Short is 5.3 points, and the client's account currency USD. Therefore, the Swap Rate Calculation: $0.2 * 5.3 = \$1.06$.

Finance Charges Calculation for CFDs

To calculate the charges for CFDs, simply use this formula:

(lots * Swap for Long or short in points * point size)

Here's an example:

A client opens a Short (Sell) position with 10 Lots on the DE40.c Index. The Swap rate for the Short position is -9.638 points.

The client's account currency is in EUR, and the Swap Rate Calculation is as follows:

$10 * (-9.638) * 0.01 = - €0.96$

Finance Charges – Commissions on Raw Spread Accounts & Commissions on Equities

GBE brokers apply flat commission charges over its Raw Spread account type and percentage commissions for Equities.

These charges will be shown separately from the trade size and it will be applied on both the opening and closing side of the trade.

A minimum flat commission is applicable when clients trade with raw spread symbols such as "ForexC" in a raw spread account. Information on our various account types can be found on our website. The commission applicable on Equities is 0.2% based on the notional value of the number of shares traded.

Finance Charges Calculation for Equities

To calculate the charges on the Equities, simply use this formula:

(lots * share price * commission percentage)

For example, let's say a client opens a Long (Buy) position with 100 share CFDs of Apple (AAPL.OQ). The market price at the time is 162 USD, and the commission is 0.1%. Therefore, the commission calculation is $100 \text{ shares} * 162 \$ * 0.2\% = \32.40

Contract Expiration & Rollover Fee

Clients that hold open positions in Futures contracts on the 'GBE brokers Expiration' date, will be debited or credited by the price difference from the closed contract to the newly opened contract along with a 20% contract rollover fee. Expirations dates will be posted on our website under the follow [link](#) for each month, informing clients which future contracts will expire within the upcoming month.

Corporate Actions / Dividends on Indices & Equities

To be eligible to receive dividends, clients must hold a CFDs position in respect of the relevant Equity or Index on the ex-dividend date.

The Equity and Index markets may be subject to a dividend adjustment to reflect that the underlying asset will open at a lower-level post-dividend date.

When a Corporate Action (CA) takes place from an individual stock which is constituent of a stock index, GBE brokers will book an adjustment to the client's account to reflect the effect this corporate action has on the stock index.

If an individual stock goes ex-dividend, long positions will be credited and short positions will be debited with a cash adjustment for positions held in the relevant index at rollover.

Long positions and short positions will be adjusted by using 100% of the relevant stock-index-adjustment. The adjustments will be made on a timely basis, however, as we are dependent upon notification from an external third party, GBE brokers shall not be liable for the consequences of any delayed adjustments.

Corporate Actions Formula

The basic formula used is $d = p \times n$

d = dividend p = position

n = dividend declared / number of index points (dividend amount)

Here's the calculation we use for the dividend for equities:

A client opens a Long (Buy) position on 10,000 share CFDs of Apple (AAPL.OQ), with a net dividend declared at 2p.

The calculation is: $d = 10,000 \times 0.02 = \200 (credited).

Another example is when that a client opens a Short (Sell) position on 5,000 share CFDs of Deutsche Bank (DBKGn.DE), with a net dividend declared at 5p.

The calculation is: $d = 5,000 \times 0.05 = \text{€}250$ (debited).

Dividend Calculation for Index CFDs

Let's take a look at an example on how we calculate the dividends for the Index CFDs.

A client opens a Long (Buy) position on 10 CFDs of US30, with a dividend at 8 index points.

The calculation is: $d = 10 \times 8 = \$80$ (credited).

Another example is that of a client that opens a Short (Sell) position on 10 CFDs of UK100, with a dividend at 5 index points.

The calculation is: $d = 10 \times 5 = \text{£}50$ (debited).
